Qualifications for Director of said <u>California Water Districts</u> are that (s)he shall be a holder of title to land within the district, or the legal representative of a holder of title to land within the district in accordance with Water Code Section 34030 or a representative designated by a holder of title to land within the district, if the holder has filed with the district written evidence of that designation, may serve as director as defined in Water Code Section 34700.

Qualifications for Director of said <u>County Water Districts</u> are that (s)he shall be a voter of said district as defined in Water Code Section 30500.

Qualifications for Director of said <u>Health Care District</u>: Pursuant to Health and Safety Code Sections 32100 and 32100.1, "Each director shall be: (a) A registered voter residing in the district. (b) He or she shall have resided in the zone from which he or she is elected for 30 days next preceding the date of the election."

Qualifications for Director of said <u>Fire Protection Districts</u> are that (s)he shall be a resident and registered voter of said district or a resident and registered voter of said zone/division, as defined in Health and Safety Code Section 13841.

Qualifications for Director of said <u>Community Services Districts</u> are that (s)he shall be a registered voter residing within the boundaries of the district as defined in Government Code Section 61040.

Official Declaration of Candidacy forms for eligible candidates desiring to file for any of the offices enumerated above may be obtained from the Lake County Registrar of Voters office in person at 325 N Forbes Street, Lakeport, CA 95453 during regular office hours of 8:00 a.m. to 5:00 p.m. Monday through Friday.

<u>Please be aware that the filing period begins on Monday, July 15, 2024 and ends on Friday, August 9, 2024 at 5:00 p.m.</u>

Appointment to each elective office will be made as prescribed by Elections Code Section 10515 in the event there are no nominees or insufficient number of nominees for the office and a petition for an election is not filed with the elections official within the time period prescribed by Elections Code Section 10515. The person appointed shall qualify and take office and serve exactly as if elected at a General District Election for such office.
